**GENERAL TERMS AND CONDITIONS**

1. The agency shall enact regular pick-ups of documents, parcels etc from our premises at National Council for Cement and Building Materials, 34 KM Stone, Delhi-Mathura Road (NH-2) Ballabgarh-121004, Haryana, daily in the evening at mutually agreed time and also as and when required.
